**General Information**

- ✓ Must be a CEC active Member

**Rebate requirements**

- ✓ Must provide Energy Star certified model number for all appliances
- ✓ For Smart thermostats- Thermostat(s) must be installed at the consumer account location.
- ✓ Itemized receipt (*proof of purchase*) is required for each item.
- ✓ Replacement of existing gas cooktop/range units require verification; photographs of the old unit are sufficient.
