

## **CEC Board Approves expanded Rebates for Members**

Columbus Electric Cooperative, Inc., in conjunction with is power supplier, Tri-State Generation & Transmission Association, will continue to partner to offer members rebate programs for 2022!

As a result, the following rebate programs are available to our members:

**Appliance Rebates**- Includes refrigerators, freezers, washers, dryers, induction cooktops, and smart thermostats. You can also get a rebate for recycling your old refrigerator or freezer too!

**Electric Motor Rebates**- Commercial and industrial motors with horsepower from 10 through 1,500 hp and variable speed drive retrofits with horsepower from 25 on up.

**Heat Pumps Rebates-** Includes electric air source and ground source heat pumps.

Outdoor Power Equipment- Includes electric mowers, snow blowers, electric trimmers, chainsaws, power washers, pruners, and blowers.

Water Heater Program- This is one of our more popular programs. It includes 40- and 50-gallon electric water heaters for a nominal fee.

Members can also get a rebate for electric bicycles, electric forklifts, electric pallet jacks, and commercial lighting.

Members have <u>90</u> days from the date of purchase to apply for a rebate and must provide proof of purchase, so save those receipts!

## **Board Highlights**

The Board of Trustees at the January meeting voted to hold the 2022 Annual Meeting on Saturday, April 9, 2022. The meeting will be held at the Animas Schools. Members can expect to receive official notice of the meeting in March pursuant to the Cooperative by-laws. Due to the pandemic, bus transportation will not be provided this year. The Board of Trustees will be proposing an amendment to the bylaws at the annual meeting. amendment is to establish clarity on a process for amending the by-laws. Trustees also voted to retire capital credits earned by members in 1993 and a portion of 1995. The Cooperative operated at a loss in 1994 so no margins were allocated that year. The Cooperative will distribute a total of \$315,149.39 back to members.
