

# **2021 ENERGY EFFICIENCY PROGRAMS**

The Columbus Electric Cooperative Board approves the 2021 Energy Efficiency Programs, which have been in place since the 1990's and are intended to encourage and reward energy efficiency purchases and energy use practices. We are happy to report that our power supplier, Tri-State Generation & Transmission Association, for 2020 will once again partner in the programs we offer to our members. As a result, following is a list of programs available to our members in 2021.

Electric water heaters are available for sale to members by visiting or calling our office.

- 40 gallon/ \$50
- 50 gallon/ \$60

**Energy Star Appliances -** A complete list of qualifying appliances is available at <u>www.energystar.gov</u>

- \$30/unit full size refrigerators or freezers
- \$60/unit for refrigerator/freezer recycling
- \$40/unit for front load clothes washers
- \$30/unit for clothes dryer (electric only) and top load clothes washers
- \$90/unit for hybrid heat pump clothes dryer (ventless)
- \$20/unit for dishwashers

#### **Electric Heat Pump**

- \$300/ton for units rated from 15 to 17 SEER (not to exceed 50% equipment cost)
- \$450/ton for units greater than 17 SEER (not to exceed 50% equipment cost)
- \$100/unit additional incentive for central air source with integrated controlled ETS backup in lieu of separate ETS incentive
- \$85/unit for terminal units or window mounted air-source heat pumps
- Rebates available for ground source units

### Energy Star split system air-conditioners

• \$100/unit for units 16 SEER or greater

# **REBATES FOR OUR IRRIGATION** <u>MEMBERS</u>

#### **Motor Rebate Amount**

- \$8/horsepower from 10 through 1,500 horsepower
- \$1.50/horsepower wiring assistance if the motor replaces a fossil-fueled engine, or is a new installation

#### Variable speed drive (VSD) retrofit

- New and retrofit application
- The incentives will be the lower of:
  - 50% of the cost of the VSD unit or,
  - Project cap of \$20,000
  - Reference table available
- Replacement of existing VSDs, for maintenance or other purposes, does not qualify
