

NOTICE OF INCREASE IN RATES AND CHARGES
COLUMBUS ELECTRIC COOPERATIVE, INC.
DOCKET NO. E-01851A-24-0206

In Decision No. 80895, dated May 12, 2025, the Arizona Corporation Commission approved a rate increase requested by Columbus Electric Cooperative, Inc. to levy the rates and charges listed below effective for May 2025 usage billed on or after June 1, 2025.

The revised rates and charges for each customer class are set forth below. Under the approved rates a residential customer's bill with an average usage of 569 kWh per month will increase \$7.88, from \$92.11 to \$99.99, or 8.55 percent.
