Electric Heat Pumps and Whole House Fans

General Information

- ✓ No other Columbus Electric Cooperative energy efficiency credit of special rate or discount shall apply.
- ✓ Rebate must be requested within 90 days of purchase
- ✓ Must be a CEC active Member

Efficiency Standards

Incentive for Electric Heat Pump- Air Source

Ductless Air-Source Heat Pump

- Minimum eligibility- EnergyStar version 6.1 and/or – 7.8 HSPF2
 - \$500 for systems equal to or, less than 1.5 tons (18,000 BTUs)
 - \$1,500 for systems greater than 1.5 tons (18,000BTUs)
 - Rebate cannot exceed 50% of equipment cost

Ducted Air- Source Heat Pump

- Minimum Eligibility- EnergyStar version 6.1 and/or – 7.8 HSPF2
 - \$500 for systems equal to or, less than 1.5 tons or 18,000 BTUs
 - \$1,500 for systems greater than 1.5 tons or 18,000 BTUs
 - \$500 bonus for dual-fuel heat pump combined with propane and natural gas
 - Heat pump required to provide at least 50% of heated area down to 17 degrees Fahrenheit

Air to Water Heat Pumps

- \$500/ton

Incentive for Electric Heat Pump- Ground Source

- \$500 per ton for new systems including the field or well(s)
- \$250 per ton for replacement of the heat pump equipment only
- \$100 per unit for ground source heat pump powered hot water (a.k.a. desuperheater)
- EnergyStar rating not required
- New or replacement ground source heat pumps with closed-loop or open-loop water source heat pumps qualify

Incentive for Whole House Fans

\$100 for replacement or new installations

Limit 2 whole house fans per member account

Incentive for Evaporative Cooler

\$200 for replacement or new installation

Limit 2 evaporative coolers per member account

Rebate Requirements

- ✓ Must provide proof of purchase (*itemized receipt or invoice*) for air or ground source heat pumps, whole house fans and evaporative coolers. Receipts(s) must be legible and clearly show detailed product make and model information.
- ✓ Back-up and/or hot water storage tanks associated with a desuperheater are not eligible for additional rebates. (*a desuperheater is an optional heat transfer device for domestic water-heating from a ground source heat pump*)
- ✓ Window and/or portable evaporative cooler units are not eligible
- ✓ Evaporative Cooler- Minimum air flow rate is 2,500 CFM
